SHARE PURCHASE PLAN UPDATE

On 29 April 2009 RIMCapital Limited (ASX Code: RMC) ("the Company") announced that it was undertaking a Shareholder Share Purchase Plan ("Plan") to eligible shareholders of the Company.

The Company advises that proceeds of \$64,500 were received under the terms of the Plan.

The issue price for shares offered under the Plan was the lower of:

- (1) 5.0 cents per share (being 82% of the average market price of the Company's shares calculated over the last five (5) trading days on which sales in the Company's shares were recorded before the date of announcement of the Plan on 29 April 2009); or
- (2) 80% of the Company's average share price over the last five (5) trading days before the day on which the issue is made under the Plan.

The Company advises that the issue price for shares under the Plan is 3.5 cents and that accordingly 1,842,852 fully paid ordinary shares have been allotted and issued to participating shareholders. Confirmation statements were mailed out to the relevant shareholders today.

An Appendix 3B in respect these new shares issued under the Plan is attached to this announcement.

The Company will keep shareholders and the market informed in relation to other capital raising initiatives as appropriate.
